Radiotherapy (the clinical use of radiation to kill cancer cells) plays a part in the treatment of many types of cancer, and the technology by which it is delivered is advancing all the time. CTRad draws on a wide range of expertise across the UK to focus on clinical and translational issues relating to radiotherapy and radiobiology, as well as developing a portfolio of practice-changing trials. The group is also responsible for actively promoting the translation of new discoveries into practice. CTRad is led by an Executive Group, which oversees four Workstreams, each of which has a separate area of responsibility.

- Excellent communication skills with an ability to listen to others
